

3. AMC Charges for 4th & 5th year will be at 15% & 20% respectively for media player; For software AMC will be at 8%. It will increase y-o-y by 1%.
4. The delivery period for the material is 4-5 weeks after PO & advance is received.
5. Payment terms: (i) 50% in advance & (ii) 50% before delivery.
6. The above quotation is subject to change based on government policies. Import duties on electronic components are likely to change which will have a proportional effect on this item.
7. GST amount for Media Player(s) and Software is 18%.

XtremeSignage Standard Terms and Conditions

1	Xtreme Media offers the services of Digital Signage, Meeting Room Management, Queue Management, Wayfinding, Flight Information Display System in its bucket of XtremeSignage Solutions.
2	XtremeSignage Solution is provided via cloud server services (SAAS), on premise solution &standalone solution (application & media output source is same).
3	For SAAS Subscription, license is valid for one year from the date of purchase or otherwise as ordered. 1 GB storage space and 4GB network bandwidth will be provided per license. Additional storage/bandwidth if required, must be purchased extra at actual. Charges are as follows 100 GB BW Rs. 2500 & 10 GB Storage Rs. 2500. Support is extended for the period of the license validity.
4	For on-premises & standalone solution, license is for lifetime and support is extended for the period of service under warranty/AMC.
5	Installation for all servers are done online. For onsite installations, extra charges are applicable.
6	Support will be provided on valid support ticket logged on our help desk on: https://helpdesk.xtreme-media.in
7	Players for SAAS services will be dispatched after registering on the cloud.
8	On premises digital signage software will be installed online on the hardware provided by client and media players will be configured with the assistance of the client's IT personnel.
9	System hosting the XtremeSignage server software application must not be utilized for hosting other applications for optimum performance.
10	Operating software and antivirus licenses for the system hosting the XtremeSignage server software application will be in the client's scope unless specified otherwise.
11	XtremeSignage server software application can be hosted on Windows, Ubuntu and RHEL OS
12	For hosting the XtremeSignage server software application, Xtreme Media will share the required network ports and client has to ensure availability of the same.
13	Client will provide secure access of XtremeSignage server software application every 6 months for health check-up and system upgradation during warranty and AMC period. This is applicable for all support calls logged.
14	For hosting the XtremeSignage server software application, a system with minimum or better specifications than shared in prerequisites has to be provided by the client
15	In case of no special / separate agreements are signed, Xtreme Media SLA will be applicable for all client support
16	Xtreme Media is not responsible for any shortage of services arising due to network
17	Xtreme Media hardware comes with pre-defined warranty. Accessories like Adaptor, HDMI Cable, etc. carry a warranty of 6 months from date of dispatch.
18	The default length of the HDMI cable provided by Xtreme Media is of 1 meter. If more than this is required, it will be charged additional.
19	If any hardware under warranty requires a replacement, same will be provided only against receipt of the faulty hardware at our corporate office at Mumbai.
20	In case additional licenses are purchased on existing user license, all existing licenses will have to be extended up to new expiry period at applicable charges.

21	Warranty is void in case of any physical damages found to the player due to mishandling, power surges etc.
22	For Wayfinding, MRM and QMS, User Interface from available templates to be chosen.
23	Customization of User Interface will entail extra charges and time.
24	For Wayfinding, the floor maps will be designed with maximum 4 color combinations.
25	For Wayfinding, Xtreme Media will extend their services for one change per month in the period of Warranty / AMC. Additional changes will be chargeable.
26	All players must be connected to a working internal / Public network for communication with digital signage application. Any issues arising due to client provided network hardware or cabling are not attributed to Xtreme Media.
27	Sharing details of displays with its firmware is essential for compatibility verification of the XtremeSignage server software application in case of smart scenes.
28	All Xtreme Media digital media players come with inbuilt storage. Part of the storage will be utilized for the digital signage application. Actual usable player storage will be different and depends upon the player model and type.
29	Mounting of media player not included in the cost quoted by Xtreme Media.

Standard Hardware Specifications Required for Hosting Applications

1	If the player quantity is 1 to 50, then it should have CPU 4 core, 8 GB RAM and 250GB storage.
2	If the player quantity is 51 to 1000, then it should have CPU 8 core, 16 GB RAM and 500GB storage.
3	If the player quantity is 101 to 500, then it should have CPU 16 core, 32 GB RAM and 1TB storage.
4	If the player quantity is 501 to 1000, then it should have CPU 32 core, 64 GB RAM and 1TB in raid 1 storage.
5	If the player quantity is 1001 and above, then it should have CPU 32 core, 128 GB RAM and 2TB in raid 5 storage.

Standard Network Requirement for DSS Applications

1	For communication between server and player, we need Ports number of a network 80/443, 21, 8000, 30000-30020 and 123 to be open.
2	For communication between player and server, we need Ports number of a network 22,5901 and 5986 ports to be open.
